21/36 Minutes:

The minutes of the meeting held on 9th August 2021, having been circulated were accepted as a true record and signed by the Chairman.

21/37 Co-option of new Councillor:

Mr Derek Wightman was unanimously co-opted to fill the vacant seat on the Council. He then signed the Declaration of Acceptance of Office. He declared an interest in Planning Application SL//2021/0995 (Land at Crabtree Farm, Crabtree Lane, Lupton).

21/38 Reports from County and District Councillors:

Councillor Harvey said that the present County Council and six District Councils would be replaced in 2023 by a Unitary Authority, 'Westmorland and Furness'. It is expected that there will be 60 Councillors in the new Authority, with a 30/30 East/West split. A 'shadow Authority' will operate from 2022.

21/39 Finance:

- b. The Chairman said the new Bank Mandate (minute 21/27f refers) is in hand.
- c. The Budget Report, prepared by the Clerk, was considered and it was resolved that this Council makes a Precept upon South Lakeland District Council in the sum of £4,100 for the financial year 2022-23.

The notice board is now ready although the grant for it is still awaited. It was resolved that a seat is placed in the bus shelter and a small window made. The Council agreed to finance these improvements.
